Entry conditions:

Only a fully completed entry form can be acknowledged and processed by Project 1 Drivetime GmbH.

With the „Application for Driver Entry“ the driver also indicates if he wants to compete in the Rookie Classification.

Only BMW M2 CS Racing in the 365 hp version, run by the series organisation, are eligible to compete in the championship.

Adherence of the entry conditions is prerequisite for the integrated advancement opportunities.

Classification:

There is an overall rating for all participating drivers with continuous scoring by finish. All final results of 2024 season races will be taken into account. In addition, there is one more rating (Rookie).

Drivers Classification:

The driver with the highest score after all of the races in the BMW M2 Cup is awarded the title: BMW M2 Cup Champion 2024.

All of the official and final results of the events (training and races) from the year 2024 are considered.

Additionally the series organisation can apply one (or more) so called guest drivers. These guest drivers don't receive championship points, furthermore their cars will be given away from a separate contingent.

Furthermore the series organisation can apply one (or more) so called VIP-Cars. This car is not rotating between the race weekends and therefore is not eligible for any championship points. The series organisation informs about the usage.

Rookie Classification:

A driver is considered a rookie participant ((Age group, year of birth 2002 or later), who will start in the BMW M2 Cup for the first time in 2024 or did a maximum of guest appearances in 2023.

Participation in the rookie competition must be indicated on the registration form.

The series organiser reserves the right to refuse entry forms for the rookie classification by stating reasons.

A guest start refers to a full race weekend that includes free-practice, qualifying and two races.

The rookie classification needs a minimum of five drivers.

Registration deadline for Driver Entry is the 31st of March 2024.

The driver mentioned above is only permitted to start at the BMW M2 Cup 2024 if the „Application for Driver Entry“ is confirmed by the series organiser.

A complete „Application for Driver Entry“ includes the following:

- Completed and signed „Application for Driver Entry“
- Copy of a valid national 2024 driver licence
- Permanent permission to start at races abroad

(for drivers not from Germany)

- Copy of ID and passport (driver)
- Reference to the present „Application for Driver Entry“ form

Entry fees for the season and per event:

The registration/entry fees as well as a possible deposit are payable as specified on the entry form. The following registration/entry fees are due immediately and payable by the participants: 130.000 € (one hundred thirty thousand Euros) plus VAT:

Only a fully paid registration/entry fee and a careful audit from the organiser/promoter make a valid „Application for Driver Entry“.

If the series organiser/promoter receives entries after the end of the entry deadline, the entry fee payable increases automatically to € 140.000 plus VAT.

Drivers who competed in the championship but quit before the end of the season (without any written and permitted notice to the series organiser) are not eligible for a refund of a proportional entry fee.

All the accepted participants will receive a written confirmation of their registration.

The series organiser reserves the right to refuse entry forms, with having to give reasons.

Early-Bird:

Drivers who enroll for the championship before the 31st of December 2023 and pay the full enrollment fee in time get access to the following services for free:

- 10.000 € discount on the enrollment fee of 130.000 €
- An additional test in the BMW M2 CS Racing
- Performance diagnostics at the German Sport University Cologne
- Exercise plan and control via the ATLETA platform
- Simulator training at the Project 1 Drivetime HQ in Lohne
- Follow up diagnostic just before the start of the season in March

Money and Trophies:

The top three drivers of the Drivers Classification of the BMW M2 Cup 2024 win the following advancement opportunities after the end of the season:

1. Place: The first-placed driver in the driver's championship receives a GT4 Cock-pit for the 2025 season subsidized with 150.000 € with the team Project 1.
2. Place: The second-placed in the driver's championship will receive a GT4 Cockpit for the 2025 season for the price of the BMW M2 Cup season 2024 (130.000€) with the team Project 1.
3. Place: The third-placed in the driver's championship receives an invitation to a test in a BMW GT4 after the 2024 season.

The subsidized advancement opportunities (Prizes) refer to the running costs of the car and pure participation in the given race series. As in the BMW M2 Cup further costs for insurance, travel etc. can occur. The series organiser will inform you with further details.

Damage and insurance in the event of damage:

Every enrolled driver needs to pay the insurance fee for the BMW M2 CS of 11.600 € which is due immediately upon registration and needs to be paid to the bank account of the series organiser (for details please see DMSB General Regulations BMW M2 Cup 2024 part 1 article 4.2).

To ensure a fair and quick processing, every driver gets an individual account at the Project 1 Drivetime GmbH for billing possible repairs/damages. The self deduct of 10.000 € needs to be deposited on this account before the next BMW M2 Cup session. The series organiser informs about the bank account balance and a possible difference that needs to be added. A credit card to compensate the balance during the weekend is recommended.

The individual account at the Project 1 Drivetime GmbH will be opened together with the series organiser after a successful „Applications for Driver Entry“.
